**Horse Show #4 & 5 entries close at midnight Friday, May 3.** Scratch after cattle are ordered results in loss of cattle fee. Scratch after Draw, results in loss of Addback, Office and Cattle fees. Herd Practice will consist of 60 spots on Wednesday afternoon, and 60 spots on Thursday morning. Late entries may be accepted if cattle are available, with a late fee.

**Shoot Out** eligibility based on highest combined cow scores in **CRCHA** classes. **Fence Shoot Out** to take place on Saturday, following **Complimentary Dinner**. **Boxing Shoot Out** will be upon conclusion of Show 5 on Sunday. No entry fee for Shoot Outs. Shoot Out Champions will each receive a custom made Martin Saddle.
