Herd Practice will consist of 60 spots on Friday afternoon, with priority to 3 year olds. **Registered name required for each 3 yo. Only one herd work per horse.** Late entries may be accepted if cattle are available, with a late fee.

Featured Class: Open Bridle will be held on Saturday evening, with the NRCHA added money increased to \$1500 and a custom belt buckle to the CRCHA Open Bridle class winner. Snacks and beverages will be provided.
