- 1 POINT PENALTIES:**
 A- (Miss) losing working advantage
 B- Noise directed to cattle
 C- Working out of position
 D- Toe, foot, or stirrup on shoulder

- 5 POINT PENALTIES:**
 A- Horse quitting a cow
 B- Losing a cow
 C- Changing cattle after a specific commitment
 D- Failure to separate a single animal after leaving the herd
 E- Blatant disobedience
 F- Spurring or hitting in front of the cinch at any time or excessively whipping or spurring the horse.

- 3 POINT PENALTIES:**
 A- Hot quit
 B- Cattle picked up or scattered
 C- Failure to make deep cut
 D- Back fence

- No Score:**
 A- Abuse
 B- Lameness
