## **Show Rules**

All entries (derby, spectacular & horse show) & stall, RV & dry camp reservations open Wednesday 2/5

All entries (derby, spectacular & horse show) close midnight Friday 3/7

Entry verification, stall, shavings, RV & dry camp lists posted Saturday 3/8

Late entries for cattle & draws close midnight Sunday 3/9 (derby & spectacular \$200 late fee, horse show \$30 late fee)

Cattle ordered Monday 3/10 based on entries received by midnight Sunday 3/9

Draws and stall chart posted Wednesday 3/12 based on entries received by midnight Sunday 3/9 (stall location not guaranteed for stall requests received after midnight Sunday)

Derby & spectacular entries after midnight Sunday 3/9 close noon Saturday 3/15 (\$200 late fee, drawn last)

Final derby & spectacular draws posted Saturday 3/15

Horse show entries after midnight Sunday 3/9 close 2 pm day before class (provided cattle available, \$30 late fee, drawn last)

Final horse show draws posted by 4 pm day before class

Results & judge's sheets posted 2 hrs after end of class

## **Other Important Dates & Times**

Move in no earlier than 8 am Sunday March 16

Early move in no earlier than noon Saturday available for out of area exhibitors (must contact show manager no later than 4 pm Monday March 10 to arrange no exceptions)

Move out no later than noon Monday March 24

Show office open 8 am to 5 pm on move in day Sunday March 16

Show office open 7 am to end of last class daily during event

Branding office open 3 pm to 5 pm Friday March 21

Show starts 8 am daily unless posted otherwise (first set of herd work settles 8 am daily)

## **Health Documents**

The California Department of Food and Agriculture requires a health certificate (Certificate of Veterinary Inspection) dated within 30 days and proof of a negative equine infectious anemia test (Coggins or ELISA) dated within 12 months for out of state horses entering California. See CDFA website for details. Show management does not require health certificate or Coggins for any horses attending the event.

## **Payouts**

Open derby entries are automatically entered into open divisions for which they are eligible (Intermediate Open, Limited Open). 70% of entry fee will go to the payout.

Level 1 open can be entered as its own class. 70% of entry fee will go to the payout.

Non pro derby entries are automatically entered into non pro divisions for which they are eligible (Intermediate Non Pro, Limited Non Pro). 70% of entry fee will go to the payout.

Number of places paid in derby will be determined by NRCHA rule 7.2.

Spectacular and horse show payouts will follow NRCHA rule 7.2.

## **Media Policy**

The California Reined Cow Horse Association (CRCHA) is an affiliate member of the National Reined Cow Horse Association (NRCHA) and is dedicated to preserving the vaquero tradition of training and exhibiting reined cow horses in California. Media coverage of the CRCHA, at its events (the horse shows in January and April, the double horse show circuit and shoot out in May, the horse shows in June and July and the pre-futurity and horse show in August) and premier events (the Spring Classic derby, spectacular and horse show in March and the Fall Classic futurity, derby and horse show in November) is central to the association's continuing efforts to promote and grow the reined cow horse sport in California.
